B. Idaho Falls Power

1) IFP 22-03 Transformer Purchase Resolution

21-357

Idaho Falls Power (IFP) solicited bids from qualified vendors to purchase transformers and found that vendors would not guarantee pricing or delivery. IFP and City Legal Services recommend that the City reject all bids and adopt a resolution authorizing staff to secure goods and services in the open market for power transformers in the approximate amount of \$1,101,675.75.

Recommended Action:

Reject all bids presented with bid number IFP 22-03 for the Transformer Purchase and adopt a resolution authorizing staff to secure goods and services on the open market for power transformers and give authorization to the Mayor and City Clerk to execute the necessary documents, (or take other action deemed appropriate).

2) IFP 22-04 Conductor Inventory for Idaho Falls Power

Idaho Falls Power solicited bids from qualified vendors to purchase conductor inventory for electric service. GEN PAC and IRBY were the only responsive, responsible bidders. Based on construction projections and unit bid prices, the base value is \$1,288,033.59 with a 5% tolerance of \$64,400.18 for a total cost of \$1,352,403.77.

C. Public Works

Iona Bonneville Sewer District (IBSD) - Request for Sewer Service Area
 Modification

21-356

Public Works is in receipt of a request from the IBSD to decrease the district's sewer service area boundary by 427.89 acres. The proposed sewer service area reductions are shown in the attached Exhibit Overview.

In conjunction with the reduction, the district is also requesting expanding the sewer service area in a

number of different locations totaling 379.65 acres as shown in the attached Exhibit A.

Section 8 of the Cooperative Agreement for Sewage Collection and Treatment between Idaho Falls and the district requires that enlargements to the sewer service area be approved by the City of Idaho Falls. The city had previously requested that the district not expand its sewer service area unless alternative means were secured for sewage to reach the Wastewater Treatment Plant. Currently, the Sunnyside Sanitary Sewer Trunk line carries all flow from the district to the Plant. The district did reduce its service area in response to our request and is approximately 118.34 acres smaller than when originally requested by the city.

The district's sewer service area would still be approximately 166.58 acres smaller than it was in 2016, if this request is approved.

Approval of request to modify the Sewer Service Area for IBSD (or take other action deemed appropriate).

2) Well 3 Elevated Water Tower - Location Site Change and Engineering Task Order, Addendum 3

City staff met with the Library Board to discuss the possibility of relocating the elevated water tower to the library south parking lot due to increasing anticipated costs associated with mitigation property from proposed impacts due to the Water Tower siting at the South Capital Park. The Library Board considered this request and voted unanimously to approve siting of the elevated tower at this location if it proved feasible. Furthermore, the Board discussed this during a library update to the City Council at the Work Session held on November 22, 2021.

Public Works staff has worked with design consultant Murraysmith to determine if the library south parking lot is a viable site. This engineering feasibility work has concluded and determined that the site was appropriate for siting the elevated water tower. In addition, city representatives have met with a number of stakeholders in the immediate vicinity of the proposed elevated water tower location and received positive feedback for siting the elevated tower at this location. Therefore, an addendum to the contract with Murraysmith has been developed to provide design services and preparation of bidding and construction documents for the elevated water tower at this new location. The proposed contract amount for such services to be provided is \$102,040.00.

Recommended Action:

Approval of the change in location for the Well 3 Elevated Water Tower from South Capital Park to the Library South Parking Lot; and approval of Addendum 3 to the Task Order with Murraysmith, LLC to accommodate this change in location; and authorization to City staff to take the steps necessary to implement this change in location (or take other action deemed appropriate).

1) Edits to Title 4, Chapter 6 Private Patrol Services

The Council discussed amendments to the Private Patrol Services Chapter of the City Code to provide clarity of license requirements and to be more consistent with requirements of similar City license provisions. Other Council discussion included consideration of whether the City should continue to license private patrol activities. One of the draft Ordinances attached amends the list of disqualifying activities, includes certain related waiting periods for qualification, reduces the minimum age from 21 to 18, and eliminates the current citizenship requirement. The other draft Ordinance attached rescinds the Private Patrol Services Chapter of the City Code in its entirety.

Recommended Action:

Approve the Ordinance amending qualifications for Private Patrol Services licenses in Title 4, Chapter 6 of the City Code, or rescind Title 4, Chapter 6 in its entirety under a suspension of the rules requiring three complete and separate readings and direct that it be read by title and published by summary (or consider the Ordinance on the first reading and that it be read by title or take other action).





History:

In 1978 the subject property was annexed and zoned R1, R3A, and PB. It was then platted as Parkwood Addition No 4 in 1987. In late 2018 the property was rezoned to R3A.

Staff Comments: The plat incudes 2 lots, the 1st will remain as a commercial use and the 2nd will become housing. The 2 lots meet the requirements for the R3A zone. Several of the utilities are in place and several of the easements are also in place. No Street improvements are required.

Staff Recommendation: Staff has reviewed the Final Plat and finds that it complies with the subdivision ordinance. Staff recommends approval of the plat.

Approval of the change in location for the Well 3 Elevated Water Tower from South Capital Park to the Library South Parking Lot; and approval of Addendum 3 to the Task Order with Murraysmith, LLC to accommodate this change in location; and authorization to City staff to take the steps necessary to implement this change in location (or take other action deemed appropriate).

Description, Background Information & Purpose

City staff met with the Library Board to discuss the possibility of relocating the elevated water tower to the library south parking lot due to increasing anticipated costs associated with mitigation property from proposed impacts due to the Water Tower siting at the South Capital Park. The Library Board considered this request and voted unanimously to approve siting of the elevated tower at this location if it proved feasible. Furthermore, the Board discussed this during a library update to the City Council at the Work Session held on November 22, 2021.

Public Works staff has worked with design consultant Murraysmith to determine if the library south parking lot is a viable site. This engineering feasibility work has concluded and determined that the site was appropriate for siting the elevated water tower. In addition, city representatives have met with a number of stakeholders in the immediate vicinity of the proposed elevated water tower location and received positive feedback for siting the elevated tower at this location. Therefore, an addendum to the contract with Murraysmith has been developed to provide design services and preparation of bidding and construction documents for the elevated water tower at this new location. The proposed contract amount for such services to be provided is \$102,040.00.

This Scope is for professional services between Murraysmith and the City of Idaho Falls, Idaho (City) for design of improvements to the Well 3 Elevated Tank. The terms of this work shall be in accordance with the *Agreement for Professional Engineering Services for the City of Idaho Falls, Idaho* - dated June 28, 2018.

Background

The City would like to abandon the existing elevated tank located at the Well 3 site and replace it with a new 1.0 MG elevated tank in the same area. The original Scope included the following tasks to implement these recommended improvements.

- Site analysis for the new elevated tank
- Elevated Tank style alternatives analysis and conceptual design
- Support for public involvement effort and site acquisition led by the City
- Preliminary geotechnical analysis to support site selection and final tank design
- Final design at the selected park site

During final design of the park site, Murraysmith was directed by the City to assess the feasibility of constructing the elevated tank in the Library Parking Lot. This location had not been previously considered because of its potential impact to Library patrons. Murraysmith performed an initial evaluation of the site and concluded that it would be feasible to construct a tower at this location.

This addendum is for final design of the elevated tank at the Library location.

Task 1 – Project Management

This task includes project management time for the extended project design timeline.

Task 1 Assumptions

The original SOW assumed that the project would be bid and contracted by January 2022 with 20 months for construction. This addendum assumes that the project will be bid and contracted by July 2021 (also with 20 months of construction). The addendum includes seven (7) months of additional project management time.

Task 1 Deliverables

Task 2 – Task 8

This Amendment 3 does not change Tasks 2-8 of the original task and Amendments 1-2.

Task 9- Library Site Final Design

Task 9.1 Library Site - Data Collection

This subtask includes geotechnical investigation of the Library site.

- Field investigation will include a single boring to be advanced to a depth of 25 feet in the location of the proposed tank. The boring will be backfilled at completion of exploration. Surfaces will be patched with cold-mix asphalt. Excavated soils will be left onsite in an inconspicuous location. If needed, these soils can be transported offsite for an additional fee.
- Information regarding regional geology will be provided.
- A seismic site evaluation will be conducted, and recommended Site Class and Seismic Design Parameters will be provided.
- Potential geologic hazards will be identified.
- A summary of soil conditions encountered will be provided.
- Hydrology
 - o A review of localized groundwater conditions will be included.
 - o Estimated soil infiltration rates will be provided based on soil classification.
- Foundations and Floor Slabs-on-Grade
 - o Bearing capacity for applicable foundation types will be provided.

- o Recommended frost embedment depths will be included.
- Foundation and floor slab subgrade preparation and drainage recommendations will be presented.
- Applicable pavement section recommendations will be provided.
- Fill material type and placement recommendations will be presented.
- Recommendations for construction activities including limitations for cut/fill slopes will be provided.

Task 9.1 Assumptions

- The City Water Department will help coordinate permission to access the site for the field investigation
- City will be responsible for private utility locates

Task 9.1 Deliverables

Draft and final Geotechnical Report Addendum (PDF)

Task 9.2 – Library Site Permit Review

Subtask 9.2.1 Conditional Use Permit (CUP) Review and Approval

Murraysmith will complete the CUP application and submit it, along with the required site plan, to the City Planning Department. Murraysmith will provide exhibits as required for the public hearing. After the CUP is approved, Murraysmith will complete the City's engineering template and submit for Site Plan review and approval.

As part of this task, Murraysmith will develop up to three (3) additional site renderings to support the Conditional Use Permit public hearing.

Subtask 9.2.2 Idaho Department of Environmental Quality (IDEQ)

Murraysmith will develop an updated PER for the project at the new site and submit to DEQ for review and approval.

Submittal of stamped plans to IDEQ for review and approval is included in the original SOW.

Task 9.2 Assumptions

Murraysmith will perform the design in parallel with the CUP review

- Murraysmith does not need to attend the public hearing that is required as part of the CUP review and approval process.
- There will be one (1) round of revisions to address comments for each agency review submittal. Additional reviews and associated revisions are outside the scope of work.
- Section 404 Permit from the US Army Corps of Engineers is not required.
- The construction contractor will be responsible for obtaining any permits not listed in this task (e.g. grading, erosion control, ROW).
- Submittal of plans for building permit following issuance of the CUP and final approval from IDEQ is included in the original SOW.
- Permitting fees are not included in this SOW and any fees will be paid by others.

Task 9.2 Deliverables

- PDF of CUP application and associated figures
- PDF of Site Plan Review application and associated figures
- PDF and hard copies as required for IDEQ review
- PDF of Building Permit application and associated figures

Task 9.3 – Library Site Final Design

Under this task, the design team will complete final designs and specifications for construction of the new reservoir and related appurtenances at the Library Site. With the new site, the following design elements will need to be revised:

- Traffic Control
- Frosion Control
- Site layout and grading
- Site piping
- Storm drain design
- Foundations and structural support for the reservoir, including Structural calculations required for permitting
- Tank layout (e.g. access)
- Mechanical system layout
- Electrical and instrumentation and control systems site layout

- External lightning layout
- Construction cost estimates
- Construction schedule

Subtask 9.3.1 Prepare 60% Plans and Specifications

The project team will prepare 60% technical specifications, drawings, cost estimate, and contractor prequalification documents.

Murraysmith will submit the 60% drawings for review and meet with the City to discuss comments.

Murraysmith will finalize the prequalification documents based on City comments. This task also includes time to evaluate the prequalification documents submitted by interested bidders/contractors.

Subtask 9.3.2 Prepare 90% Plans and Specifications

The project team will incorporate comments from the City's review of 60% designs and prepare 90% technical specifications, drawings, and a cost estimate.

Murraysmith will submit the 90% drawings for review and meet with the City to discuss comments.

Subtask 9.3.3 – Prepare 100% Plans and Specifications

The project team will incorporate comments from the City's review of 90% deigns and prepare stamped technical specifications, drawings and a cost estimate for IDEQ review (see Task 5). Murraysmith will incorporate comments from the IDEQ review and prepare stamped technical specifications and drawings for bidding.

Task 9.3 Assumptions

- Detailed design assumptions are as follows.
 - o It is anticipated the reservoir foundation will have a shallow, spread footing type foundation, thus not requiring a deep foundation.
 - O Design includes yard piping, valves, vaults, and connections to off-site piping that will be designed by City staff. Off-site piping will be routed to Well #3.
 - o No environmentally sensitive areas are present on the site.
 - o Reservoir and site drainage improvements will comply with City of Idaho Falls requirements and include on-site piping and subsurface detention storage. It is anticipated the storm water from the site can be discharged to the existing stormwater

drainage system in the parking lot. This system discharges into the existing storm drain system in the ROW. Downstream stormwater system has adequate capacity and does not need to be analyzed or upgraded.

- o Landscape design is not required.
- Project may be funded with state and/or federal funds. The City will lead any required loan paperwork. The City will lead any required environmental assessments. Murraysmith will include requirements for American Iron and Steel (AIS) compliance requirements.
- City will administer the prequalification advertisement and receive the prequalification submittals.

- Design meeting agendas and notes
- 60% design in PDF format
- 90% design in PDF format
- PDF and hard copies as required for the permit review set
- 100% design package in PDF format

Project Schedule

A detailed schedule is attached. Murraysmith will make every effort to complete the work in a timely manner; however, it is agreed that Murraysmith cannot be responsible for delays occasioned by factors beyond its control, nor by factors that could not reasonably have been foreseen at the time this scope was executed.

Project Budget

The work provided in this Task Order will be billed on a time and materials basis. The addendum and overall budget estimate breakdown for this work is outlined in the Table 1 below. Murraysmith will manage the work identified in this Task Order to the aggregate budget amount (Project Total) which shall not be exceeded without prior written authorization from the City. When any budget has been increased or follow-on work contracted, Murraysmith's excess costs expended prior to such an increase will be allowable to the same extent as if such costs had been incurred after the approved increase.

Payment will be made at the Billing rates for personnel working directly on the project, which will be made at Murraysmith's Hourly Rates, plus Direct Expenses incurred. Billing rates will be reviewed with the City and updated at the beginning of each calendar year. The overall project budget has been developed using estimated 2022 rates.

Subconsultants, when required by the Murraysmith, will be charged at actual costs plus a 10 percent fee to cover administration and overhead. Direct expenses will be paid at the rates shown in the table below.





The Council discussed amendments to the Private Patrol Services Chapter of the City Code to provide clarity of license requirements and to be more consistent with requirements of similar City license provisions. Other Council discussion included consideration of whether the City should continue to license private patrol activities. One of the draft Ordinances attached amends the list of disqualifying activities, includes certain related waiting periods for qualification, reduces the minimum age from 21 to 18, and eliminates the current citizenship requirement. The other draft Ordinance attached rescinds the Private Patrol Services Chapter of the City Code in its entirety.

AN ORDINANCE OF THE CITY OF IDAHO FALLS, IDAHO, A MUNICIPAL CORPORATION OF THE STATE OF IDAHO; AMENDING TITLE 4, CHAPTER 6 TO CLARIFY CONDITIONS FOR ISSUANCE OF A PRIVATE PATROL SERVICES LICENSE; PROVIDING SEVERABILITY, CODIFICATION, PUBLICATION BY SUMMARY, AND ESTABLISHING EFFECTIVE DATE.

WHEREAS, the City currently licenses companies and individuals who provide private patrol services within City limits; and

WHEREAS, conditions and disqualifications for licensing are set out in Title 4, Chapter 6; and

WHEREAS, recently the Council has reviewed the current conditions and qualifications and has determined that there are clarifications and improvements that should be made; and

WHEREAS, the Council has determined that a licensee should be at least eighteen (18) years of age due to the maturity and reasonable decision making required to carry out the activities permitted by the private patrol license, and because the minimum age requirement promotes the health, safety, and welfare of the general public; and

WHEREAS, the Ordinance sets out City private patrol services license conditions in a thorough and clear manner so that applicants, licensees, and members of the public understand them.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF IDAHO FALLS, IDAHO, THAT:

SECTION 1: Title 4, Chapter 6 of the City Code of the City of Idaho Falls, Idaho, is hereby amended as follows:

- 4-6-5: QUALIFICATIONS, PRIVATE PATROL PERSON: No person shall be issued a license as a private Patrol Person who:
 - (A) Is not at least twenty-one (21)eighteen (18) years of age.
 - (B) Is not a citizen of the United States. Where the applicant or licensee has:
 - 1. Been found guilty of, plead guilty to, received a withheld judgment, or admitted to the elements of any of the following enumerated crimes, or admitted that sufficient evidence exists which could be likely to convince a judge or jury to find the applicant or licensee to be guilty beyond a reasonable doubt, or any substantially similar provision of foreign criminal violation, notwithstanding the form of judgment(s):

No such person shall be qualified to apply to receive a license under this Chapter for a period of less than six (6) months following the date of the revocation of the license under this Subsection or for a period of six (6) months following the date the Clerk became aware of such information, whichever is later in time, unless otherwise provided in this Chapter.

Been found guilty of, plead guilty to, or received a withheld judgment, or admitted to the elements of any of the following enumerated crimes, or any substantially similar provision of foreign criminal violation, notwithstanding the form of judgment(s) for any offense involving neglect or any physical injury to, or other abuse of a child, or any of the following offenses or a similar provision in another jurisdiction, for a period of five (5) years immediately preceding the date of application for license or renewal:
 - <u>a.</u> Any crime of physical violence against persons, other than those listed in Section A.1. hereinabove.
 - b. Any felony as defined by Idaho Code, Sections 18-111 and 18-111A, other than those listed in Subsection A.1. hereinabove.
 - c. Attempt, Section 18-306, Idaho Code, conspiracy, Section 18-1701, Idaho Code, or accessory after the fact, Section 18-205, Idaho Code, to commit any of the crimes designated in this subsection.
 - d. Arson, as defined in Sections 18-801 through 18-804, Idaho Code.
 - e. Aggravated assault, Section 18-905, Idaho Code.
 - f. Aggravated battery, Section 18-907(1), Idaho Code.
 - g. Felony domestic violence, Section 18-918, Idaho Code.
 - h. Attempted strangulation, Section 18-923, Idaho Code.

- aa. Any person who is eighteen (18) years of age or older who sells, gives, or furnishes, or causes to be sold, given, or furnished, alcoholic beverages, including any distilled spirits, beer or wine, to a person under the age of twenty-one (21) years, Section 23-603, Idaho Code.
- bb. Any violation (felony or misdemeanor) of the Uniform Controlled Substances Act, Chapter 27, Title 37, Idaho Code.
- cc. Insurance fraud, Section 41-293, Idaho Code.
- dd. Damage to or destruction of insured property, Section 41-294, Idaho Code.
- ee. Reckless driving, Section 49-1401(1), Idaho Code.

- (D) Has supplied false or misleading information, failed or refused to provide or to disclose information required on the application form or by this Chapter, failed to disclose a suspension or revocation of a driver's license, or refused to authorize the investigation required herein. No such applicant or licensee shall be able to apply to receive a license under this Chapter for a period of less than six (6) months following the date of the denial or revocation of the license under this Subsection or for a period of six (6) months following the date that the Clerk became aware of disqualifying information, whichever is later in time.
- (E) Has violated any of the provisions of this Chapter during licensure. Violation of any provision of this Chapter during licensure, shall result in immediate and automatic revocation of the license. Such revocation of the license shall be effective as of the date of such violation. No such person shall be qualified to apply to receive a license under this Chapter for a period of less than six (6) months following the date of the revocation of the license under this Subsection or for a period of six (6) months following the date the Clerk became aware of such information, whichever is later in time, unless otherwise provided in this Chapter.
- (F) Where an applicant or licensee does not meet the conditions of licensure in this Chapter. ...
- 4-6-16: LICENSE; AUTHORITY: The issuance of any license under this Chapter shall not be construed as granting any power of arrest other than that granted a private person under Idaho Code and this Code. Nor shall the provisions of this Chapter be construed as authority to carry weapons contrary to the Idaho Code.
- 4-6-17: GROUNDS FOR LICENSE REVOCATION: Any license issued under this Chapter may be revoked by the City Council for any of the following reasons:
 - (A) Any violation of any provision of this Chapter.
 - (B) The conviction of the licensee in any court of any crime or offense involving violence or moral turpitude.
 - (C) Obtaining the license under any false or fraudulent pretense or statement.
 - (D) The conviction of the licensee in any court of any felony or any offense involving or concerning the sale or transportation of intoxicating or alcoholic liquor.
- 4-6-1817: AUTOMATIC REVOCATION OF LICENSE: Any license issued under this Chapter shall be revoked immediately and without notice to the licensee upon the cancellation or termination of the bond or insurance required by this Chapter unless the licensee posts a new comparable bond or obtains comparable insurance and files a certificate of such insurance with the Clerk prior to the date on which the original bond or insurance is canceled or terminated.
- **SECTION 2.** Savings and Severability Clause. The provisions and parts of this Ordinance are intended to be severable. If any section, sentence, clause, or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence,
