July 11, 2023, Planning Commission Action RE:

Planning Commission took the following action during the July 11, 2023, meeting.

- PLAT23-005: PRELIMINARY PLAT. Lincoln Parkway Division No. 1 Preliminary Plat. Northeast ¼ of Section 16, Township 2 North, Range 38 East. Generally located north of Kearney St, east of N Woodruff Ave, south of E Lincoln Rd, west of N 25th E. On July 11, 2023, the Planning and Zoning Commission unanimously voted to approve the preliminary plat with corrections of the number of buildable lots.
- RZON23-003: REZONE. Adoption of a Form Based Zoning Code for the area known as South **Downtown.** On July 11, 2023, the Planning and Zoning Commission unanimously voted to approve the adoption of the Form Based Zoning Code as presented.
- PLAT23-015: FINAL PLAT. Willard-Warr Addition Division No. 1, First Amended. The SW 1/4 of Section 20, Township 2 North, Range 38 East. Generally located north of E 17th St, east of June Ave, south of E 14th St, west of Ponderosa Dr. On July 11, 2023, the Planning and Zoning Commission unanimously voted to recommend approval of the final plat as presented.
- PLAT23-016: FINAL PLAT. Anderson Townhomes Division No. 1. The SE ¼ of the SW ¼ of Section 7, Township 2 North, Range 38 East. Generally located north of Anderson St, east of A. H. Bush Elementary School, south of Science Center Dr, west of N Boulevard. On July 11, 2023, the Planning and Zoning Commission unanimously voted to recommend approval of the final plat as presented.
- PLAT23-017: FINAL PLAT. MK Simpson Center Division No. 3. Part of the NE ¼ of Section 5. 12, Township 2 North, Range 37 East. Generally located north of MK Simpson Blvd, east of the Snake River, south of W 33rd N, east of N 5th W. On July 11, 2023, the Planning and Zoning Commission unanimously voted to recommend approval of the final plat as presented.
- PLAT22-014: FINAL PLAT. Edgewater Division No. 1 EXTENSION. Part of the SW ¼ of 6. Section 25 and the SE ¼ of Section 26, Township 2 North, Range 38 East. Generally located north of W Sunnyside Rd, east of Snake River Parkway, south of Event Center Dr, west of the Snake River. On July 11, 2023, the Planning and Zoning Commission unanimously voted to recommend approval of the final plat as presented.
