October 3, 2023, Planning Commission Action RE:

Planning Commission took the following action during the October 3, 2023, meeting.

- PLAT23-022: FINAL PLAT. Pickering Place Division No. 1. SE ¼ of Section 9, Township 2 North, Range 38 East. Generally located north of Lincoln Road, east of Whispering Pines Dr, south of E 24th N, west of N 25th E. On October 3, 2023, the Planning and Zoning Commission unanimously voted to recommend approval of the final plat to the mayor and City Council as presented.
- RZON23-005: REZONE. Rezone 3.7 acres from LC, Limited Commercial to CC, Central Commercial. Lots 1 - 48, Block 2, including the alley extending in an east west direction across said block 2, Capitol Hill. Generally located north of Whittier St, east of N Freeman Ave, south of E Elva St, west of N Holmes Ave. On October 3, 2023, the Planning and Zoning Commission voted to recommend approval of the rezone from LC to CC to the mayor and City Council as presented with a vote of 3 to 2.
- RZON23-006: REZONE. Rezone from LC, Limited Commercial and PUD Overlay to LC, Limited Commercial removing the PUD Overlay for the NE 1/4 of Section 13, Township 2 North, Range 37 East. Generally located north of US Hwy 20, east of the Snake River, south of Higham St., west of Freemont Ave. On October 3, 2023, the Planning and Zoning Commission unanimously voted to recommend approval of the rezone to the mayor and City Council as presented.
