RESOLUTION NO. 2016-

A RESOLUTION OF THE CITY OF IDAHO FALLS, A MUNICIPAL CORPORATION OF THE STATE OF IDAHO, AGREE TO THE ADOPTION OF THE FOLLOWING RESOLUTION TO CREATE SMOKE-FREE AND TOBACCO-FREE ZONES AT LOCAL PARKS; PROVIDING THIS RESOLUTION BE EFFECTIVE UPON ITS PASSAGE, APPROVAL AND PUBLICATION ACCORDING TO LAW.

WHEREAS, smoking is responsible for the premature deaths of over four hundred thirty thousand (430,000) Americans each year from lung cancer, heart disease, respiratory illness, and other diseases; and

WHEREAS, secondhand smoke is responsible for over fifty thousand (50,000) deaths among nonsmokers each year; and

WHEREAS, tobacco kills more Americans each year than alcohol, cocaine, heroin, homicide, suicide, accidents, fire, and AIDS combined; and

WHEREAS, eighty percent (80%) of tobacco users started smoking before the age of eighteen (18), and the average initiation age is twelve years old (12); and

WHERAS, every day an estimated three thousand nine hundred (3,900) young people under the age of eighteen (18) try their first cigarette and one-third (1/3) of these children will die prematurely from tobacco related illnesses; and

WHEREAS, to help role model tobacco-free behavior to children and youth; to provide children, youth, and their families with a safe, smoke-free environment.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF IDAHO FALLS, IDAHO, AS FOLLOWS:

- 1. That the areas of parks and recreational areas where children are present in the City of Idaho Falls be designated smoke-free and tobacco-free.
- 2. That the Parks and Recreation Department Director is hereby directed to post appropriate signage designating smoke-free and tobacco-free areas.
- 3. The community will be notified of this Resolution.
- 4. That is Resolution shall become effective immediately upon the date of adoption.
