In response to the COVID-19 crises, on March 19, 2020, Governor Brad Little issued a proclamation suspending the portion of Idaho Code 74-203(5) which requires government agencies to allow the public to attend public meetings in person. - 3. If you are interested in watching and listening, but not testifying, you can watch the live stream of the meeting at idahofallsidaho.gov.
- 4. A copy of the above application documents are maintained on file in the Planning Department, City Hall Annex, 380 Constitution Way, Idaho Falls.
